# A BILL FOR

An Act to appropriate from the general fund of the state of Iowa for capital improvements for institutions under the board of control, including construction of new buildings, repairs, improvements, replacements or alterations, and providing for joint control for the expenditure thereof by the board of control, the governor, and the state comptroller.

*- Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. There is appropriated from the general fund of the  
2 state to the board of control the sum of five million six hundred  
3 ten thousand dollars (\$5,610,000.00), or so much thereof as may  
4 be necessary, to be used in the following manner, to wit:

5 (1) Infirmary addition, at the soldiers' home at  
6 Marshalltown .....\$ 500,000.00

7 (2) Children's Hospital and School Unit  
8 including furnishings and equipment at the  
9 mental health institute at Independence ..... 700,000.00

10 (3) Security Hospital and Diagnostic Treat-  
11 ment Center ..... 2,605,000.00

12 (4) To supplement any prior appropriations  
13 for capital improvement items for construction  
14 of new buildings, repairs, improvements,  
15 replacements, or alterations, or for  
16 any capital expenditures the board of  
17 control may deem necessary for the proper  
18 and necessary function of any institution

19	under its jurisdiction .....	1,805,000.00
20	Total .....	<u>\$5,610,000.00</u>

1     Sec. 2. The board of control is hereby authorized and directed  
2 with the approval of the executive council to sell the excess  
3 institutional farm land and farm equipment referred to (but not  
4 limited to) in the Doane Agricultural Report to the board of  
5 control dated February 1965.

6     Two million six hundred five thousand dollars (\$2,605,000.00)  
7 of the proceeds to be derived from the sale of institutional farm  
8 land, farm equipment and production herds, less the three hundred  
9 thirty-four thousand dollars (\$334,000.00) of the proceeds from  
10 the sale of the Clive prison honor farm as provided by chapter  
11 three hundred seventy-four (374), Acts of the sixtieth general  
12 assembly, shall be credited to the appropriation provided by  
13 this Act to supplement items under section one (1), subsection  
14 four (4) and any excess is to be expended pursuant to section  
15 two hundred eighteen point ninety-four (218.94), Code 1962,  
16 unless further encumbered by other legislative action.

1     Sec. 3. When the board of control has approved a project to  
2 be financed with funds herein appropriated, a description of  
3 said project and estimated cost shall be reported to the governor  
4 and state comptroller for allocation of funds.

1     Sec. 4. Contracts, plans and specifications, or plan of  
2 operation for improvements for which funds are herein appropriated  
3 shall be submitted by the board of control to the governor and  
4 the state comptroller for approval, except that items commonly  
5 known as change orders need not be submitted to the governor and  
6 the state comptroller for approval unless such change orders  
7 actually increase the total cost of that particular project.

1     Sec. 5. Upon the completion of the contract documents and the  
2 determination of the total cost of any project as set forth in  
3 this Act, any unobligated balance remaining may be used to  
4 supplement any current or prior appropriation for capital improve-  
5 ment items for construction of new buildings, repairs, improve-  
6 ments, replacements or alterations, or for any other capital  
7 expenditures the board of control may deem necessary for proper  
8 and necessary function of any institution under its jurisdiction.

1     Sec. 6. The board of control, the governor, and the state  
2 comptroller are hereby authorized to obtain federal grants to the  
3 state to be used in connection with the funds above appropriated.

1     Sec. 7. Any unencumbered balance remaining as of June 30,  
2 1969, of the appropriation of this Act made by the sixty-first  
3 general assembly, shall revert to the general fund of the state  
4 as of June 30, 1969.

1     Sec. 8. If any section, subsection, paragraph, sentence,  
2 clause or phrase of this Act is for any reason held to be un-  
3 constitutional or invalid, such unconstitutionality or invalidity  
4 shall not affect the constitutionality or validity of the remaining  
5 portions of this Act. The general assembly hereby declares that  
6 it would have passed this Act and each section, subsection,  
7 paragraph, sentence, clause or phrase hereof, irrespective of  
8 whether any one or more of the sections, subsections, paragraphs,  
9 sentences, clauses or phrases be declared unconstitutional.

1     Sec. 9. This Act, being deemed of immediate importance, shall  
2 be in full force and effect from and after its passage and pub-  
3 lication in the Fort Dodge Messenger, a newspaper published at  
4 Fort Dodge, Iowa, and in the Algona-Kossuth Advance, a newspaper  
5 published at Algona, Iowa.
