# A BILL FOR

An Act to appropriate from the general fund of the state for the biennium beginning July 1, 1965, and ending June 30, 1967, funds for the central office of the board of regents.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. There is hereby appropriated for the central office  
2 of the state board of regents from the general fund of the state  
3 for each year of the biennium beginning July 1, 1965, and ending  
4 June 30, 1967, the sum of one hundred two thousand five hundred  
5 fifty dollars (\$102,550.00), or so much thereof as may be neces-  
6 sary, to be used in the following manner:

7 For salaries, support, maintenance,  
8 equipment and miscellaneous purposes  
9 (including board members receiving a  
10 per diem of twenty dollars (\$20.00) per

11 day) .....\$102,550.00

12 Grand total of all appropriations for all  
13 purposes for each year of the biennium for  
14 the central office of the board of regents.....\$102,550.00

1 Sec. 2. Chapter eight (8), Code 1962, shall apply to this Act.
