# A BILL FOR

An Act relating to the taking of a special federal census in cities and towns.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section four hundred four point six (404.6),
- 2 Code 1962, as amended by chapter two hundred forty-eight (248),
- 3 Acts of the Sixtieth General Assembly, is amended by adding the
- 4 following new subsection:

5 "To defray the cost of taking a special federal census."

- 1 Sec. 2. Section three hundred twelve point three (312.3),
- 2 Code 1962, is amended by inserting immediately following the
- 3 word "census" in line four (4) of subsection two (2) the words
- 4 "as corrected to reflect the results of any special federal
- 5 census taken in any city or town subsequent thereto".

- 1 Sec. 3. Section one hundred twenty-three point fifty
- 2 (123.50), Code 1962, is amended by inserting immediately
- 3 following the word "census" in line eleven (11) of subsection
- 4 three (3) the words ", as corrected to reflect the results of
- 5 any special federal census taken in any city or town subsequent
- 6 thereto".
