A BILL FOR

An Act authorizing school districts to pay for group health insurance and group life insurance for employees.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section two hundred seventy-nine point twelve
- 2 (279.12), Code 1962, is hereby amended by inserting in line
- 3 seven (7) after the word "law," the words "and may pay from
- 4 school district funds for the benefit of the employees of the
- 5 school district the cost of group health insurance plans and
- 6 group life insurance plans adopted by the board,".

EXPLANATION OF SENATE FILE 36

The purpose of this bill is to authorize school boards to provide group health insurance and group life insurance for employees.
