A BILL FOR

An Act relating to meetings of county boards on reorganization of school districts involving two (2) or more counties.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section two hundred seventy-five point sixteen
- 2 (275.16), Code 1962, is hereby amended as follows:
- 3 1. By inserting in line twenty-three (23) of such section
- 4 after the word "petition." the following:
- 5 "However, if such joint boards cast a tie vote and are unable
- 6 to agree to an order fixing the boundaries for the proposed school
- 7 district or to an order to dismiss the petition, the time during
- 8 which such actions must be taken under the provisions of section
- 9 two hundred seventy-five point fifteen (275.15) shall be extended
- 10 from five (5) days to fifteen (15) days after the conclusion of
- 11 the heading under the provisions of section two hundred seventy-
- 12 five point fifteen (275.15), and such joint board shall reconvene
- 13 not less than ten (10) and not more than fifteen (15) days after
- 14 the conclusion of such hearing. At such hearing the joint board
- 15 shall reconsider their action and if a tie vote shall again be
- 16 cast it shall be deemed an order granting the petition and chang-
- 17 ing the plans of any and all of the county boards affected by the
- 18 petition and fixing the boundaries for the proposed school corpo-
- 19 ration."
- 20 2. By adding thre to the following sentence:

21 "The provisions of this section shall apply to all tie votes
 22 under any provision of this chapter where a joint meeting of the
 23 members of two (2) or more county boards of education are required
 24 and to all petitions pending on the effective date of this Act.

25 3. By striking from line twenty-four (24) of such section the
 26 word "this" and inserting in lieu thereof the word "the".

1 Sec. 2. This Act, being deemed of immediate importance, shall
 2 take effect and be in force from and after its publication in the
 3 _____, a newspaper published in
 4 _____, Iowa, and in the _____,
 5 a newspaper published in _____, Iowa.
