# A BILL FOR

An Act to amend section seventy-nine point one (79.1), Code 1962, relating to the payment of accrued vacation pay to employees of the state whose employment is terminated.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section seventy-nine point one (79.1), Code
- 2 1962, is hereby amended by adding the following after the word
- 3 "commission." in line twenty-one (21) of said section:
- 4 In the event that the employment of an employee of the
- 5 state who has been in such employ for more than one (1) year
- 6 shall be terminated for any reason other than a discharge for
- 7 good cause, he shall be paid a vacation allowance for any
- 8 vacation which may have accrued to him during the twelve (12)
- 9 months immediately prior to such termination, and which he
- 10 has not yet taken.
- 11 Vacation allowances for any period of less than one (1)
- 12 year shall be computed as having accrued at the rate of two and
- 13 one-half (2 1/2) days pay for each completed calendar quarter
- 14 during the second (2nd) and through the ninth (9th) year of
- 15 employment, and at the rate of three and three-fourths (3 3/4)
- 16 days pay for each completed calendar quarter through the
- 17 tenth (10th) and all subsequent years of employment.
- 18 If said termination of employment shall be by reason of
- 19 the death of the employee, such vacation allowance shall be

- 20 paid to the estate of the deceased employee if such estate
- 21 shall be opened for probate. If no estate be opened, the
- 22 allowance shall be paid to the surviving spouse, if any, or
- 23 to the legal heirs if no spouse survives.
