A BILL FOR

An Act to eliminate the finance committee of the state board of regents and provide for the board of regents to create committees, offices and agencies and delegate powers and duties and establish rules and regulations therefor.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Sections two hundred sixty-two point twelve
2 (262.12), two hundred sixty-two point thirteen (262.13), and two
3 hundred sixty-two point twenty-one (262.21), Code 1962, are
4 hereby repealed.

1 Sec. 2. Chapter two hundred sixty-two (262), Code 1962, is
2 amended by adding a new section as follows:

3 "The board of regents shall also have and exercise all the
4 powers necessary and convenient for the effective administration
5 of its office and of the institutions under its control, and to
6 this end may create such committee, offices and agencies from
7 its own members or others, and employ persons to staff the same,
8 fix their compensation and tenure and delegate thereto, or to
9 the administrative officers and faculty of the institutions under
10 its control, such part of the authority and duties vested by
11 statute in the board, and shall formulate and establish such
12 rules and regulations, outline such policies and prescribe such
13 procedures therefor, all as may be desired or determined by the
14 board as recorded in their minutes. Employees of the board
15 hereunder shall not come under the division of personnel provided

16 for in section eight point five (8.5), Code 1962."

1 Sec. 3. Section two hundred sixty-two point nine (262.9),
2 Code 1962, is hereby amended by striking all of subsection eleven
3 (11) after the word "it" in line three (3).

1 Sec. 4. Section two hundred sixty-two point ten (262.10),
2 Code 1962, is hereby amended by striking from line eight (8) the
3 words "finance committee" and inserting in lieu thereof the words
4 "any of its committees, offices or agencies".

1 Sec. 5. Section two hundred sixty-two point fourteen (262.14),
2 Code 1962, is hereby amended as follows:

3 1. By striking from lines one (1) and two (2) the words
4 "finance committee" and inserting in lieu thereof the word "board".

5 2. By striking from line two (2) of subsection three (3) the
6 words "by the finance committee".

7 3. By striking from line eight (8) of subsection four (4)
8 the words "the finance committee,".

9 4. By striking from lines three (3) and four (4) of subsection
10 five (5) the words "the secretary of said committee" and inserting
11 in lieu thereof the word "board".

1 Sec. 6. Section two hundred sixty-two point fifteen (262.15),
2 Code 1962, is hereby amended by striking from line two (2) the
3 words "finance committee" and inserting in lieu thereof the word
4 "board".

1 Sec. 7. Section two hundred sixty-two point sixteen (262.16),
2 Code 1962, is hereby amended as follows:

3 1. By striking from line two (2) the words "finance committee"
4 and inserting in lieu thereof the word "board".

5 2. By striking from lines two (2) and three (3) of subsection

6 one (1) the words "chairman or secretary of said committee" and
7 inserting in lieu thereof the words "treasurer of the institution
8 to which the loan belongs".

9 3. By striking from lines three (3) and four (4) of subsection
10 two (2) the words "chairman or secretary of the committee" and
11 inserting in lieu thereof the words "treasurer of the institution
12 to which the loan belongs".

1 Sec. 8. Section two hundred sixty-two point twenty (262.20),
2 Code 1962, is hereby amended by striking the period and all of
3 such section after the word "learning" in line three (3) and
4 inserting in lieu thereof the words ", with such organizations,
5 powers and duties as the board may prescribe and delegate."

1 Sec. 9. Section two hundred sixty-two point twenty-two
2 (262.22), Code 1962, is hereby amended by striking all of such
3 section after the word "for" in line three (3) and inserting in
4 lieu thereof the words "services and expenses of officers and
5 employees of the board of regents and to whom paid."

1 Sec. 10. Section two hundred sixty-two point twenty-three
2 (262.23), Code 1962, is hereby amended by striking from line two
3 (2) of subsection two (2) the words "the finance committee" and
4 inserting in lieu thereof the words "such committee or official
5 as it designates,".

1 Sec. 11. Section two hundred sixty-two point twenty-six
2 (262.26), Code 1962, is hereby amended by striking from line nine
3 (9) the words "and finance committee".

1 Sec. 12. Section two hundred sixty-two point twenty-nine
2 (262.29), Code 1962, is hereby amended by striking from lines
3 three (3) and four (4) the words "the finance committee and of

4 their assistants" and inserting in lieu thereof the words "its
5 committees, offices, agencies and employees".

1 Sec. 13. Section sixty-four point six (64.6), Code 1962, is
2 hereby amended by striking subsection four (4),

1 Sec. 14. Section nineteen point twenty-five (19.25), Code
2 1962, is hereby amended by striking from lines one (1) and two
3 (2) of subsection eighteen (18) the words "the finance committee
4 thereof" and inserting in lieu thereof the words "its committees
5 and officials designated by the board therefor."

1 Sec. 15. Section two hundred seventy-one point ten (271.10),
2 Code 1962, is hereby amended by striking from line two (2) the
3 words "the finance committee of" and inserting in lieu thereof
4 the words "such official as may be designated therefor by".

1 Sec. 16. Section two hundred seventy-one point eleven
2 (277.11), Code 1962, is hereby amended by striking from line
3 three (3) the words "finance committee" and inserting in lieu
4 thereof the words "said official designated by the board of
5 regents".

1 Sec. 17. Section two hundred twenty-five point twenty-eight
2 (225.28), Code 1962, is hereby amended by striking from line
3 twelve (12) the words "the finance committee of".
