A BILL FOR

An Act to make appropriations to certain named persons in settlement of claims made against the state of Iowa.

Be It Enacted by the General Assembly of the State of Iowa:

 23 fifteen (15), the words "department of public safety salaries"
 24 and inserting in lieu thereof the word "general".
 25 8. By striking from line five (5), section sixteen (16),
 26 the words "department of public safety salaries" and inserting
 27 in lieu thereof the word "general".
