An Act to make appropriations to members of the legislative research committee and the highway study advisory committee.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated out of the general
2 fund of the state of Iowa to the following named persons the
3 amounts set opposite their respective names in full settlement
4 of all claims which they may have against the state of Iowa on
5 account of services rendered as a member of the legislative re-
6 search committee or the highway study advisory committee estab-
7 lished by the legislative research committee by the authority of
8 sections two point fifty-five (2.55) and two point fifty-six (2.56),
9 Code 1962.
