# A BILL FOR

An Act to appropriate from the general fund of the state for the biennium beginning July 1, 1965, and ending June 30, 1967, funds for the state conservation commission.

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. There is hereby appropriated for the office of
- 2 the conservation commission from the general fund of the state
- 3 for each year of the biennium beginning July 1, 1965, and end-
- 4 ing June 30, 1967, the sum of one million thirty-seven thousand
- 5 eight hundred forty dollars (\$1,037,840.00), or so much thereof
- 6 as may be necessary to be used in the following manner:
- 7 For salaries ..... \$ 784,845.00
- 8 For support, maintenance, and miscellaneous
- 9 purposes of the office, maintenance of state parks,
- 10 waters and forests, and for the construction and im-
- 11 provement of roads and highways under its control .... 157,465.00
- 12 For prison labor program (including salaries)
- 13 for utilization of prison inmates under the board of
- 14 control ..... 95,530.00
- 15 The salary of the state conservation director
- 16 shall be twelve thousand dollars (\$12,000.00) for
- 17 each year of the biennium beginning July 1, 1965,
- 18 and ending June 30, 1967.
- 19 Grand total of all appropriations for all
- 20 purposes for each year of the biennium for the

21 conservation commission .....\$ 1,037,840.00

1 Sec. 2. Section one hundred seven point thirteen (107.13),  
2 Code 1962, as amended by chapter one hundred, Acts of the sixtieth  
3 general assembly, is amended as follows:

4 1. By striking from lines fifteen (15) and sixteen (16)  
5 the words "forty-two hundred eighty (4,280) and inserting in lieu  
6 thereof the words "forty-eight hundred" (4,800).

7 2. By striking from lines twenty (20) and twenty-one (21)  
8 the words "fifty-one hundred eighty" (5,180) and inserting in  
9 lieu thereof the words "fifty-nine hundred seventy" (5,970).

1 Sec. 3. Section one hundred seven point thirteen (107.13),  
2 Code 1962, is amended by striking from line twenty-seven (27),  
3 lines thirty-two (32) and thirty-three (33), line forty (40),  
4 and lines forty-seven (47) and forty-eight (48) the words "fifteen"  
5 and inserting in lieu thereof the words "twenty-five".

1 Sec. 4. Chapter eight (8), Code 1962, shall apply to this  
2 Act.
