A BILL FOR

An Act to appropriate funds from the general fund of the state of Iowa to the department of public instruction for construction of four (4) vocational schools.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is appropriated to the department of
2 public instruction from the general fund of the state of Iowa
3 the sum of six million dollars (\$6,000,000.00), or so much
4 thereof as may be necessary, to match federal funds to be
5 expended by the United States treasury, for construction of
6 four (4) area vocational schools.

1 Sec. 2. The funds appropriated and set aside by this Act
2 shall be released by the governor and the state comptroller
3 upon the recommendation of the majority of the advisory board
4 and the state board of public instruction.

1 Sec. 3. Any unencumbered balance remaining as of
2 June 30, 1969, of the appropriation of this Act made by the
3 sixty-first (61st) general assembly, shall revert to the
4 general fund of the state as of June 30, 1969.
