A BILL FOR

An Act relating to the fee for a class "C" beer permit.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section one hundred twenty-four point twenty-
2 four (124.24), Code 1966, is amended by deleting in line
3 twenty-eight (28) the words "twenty-five dollars." and
4 inserting in lieu thereof the following:
5 "fixed by the authority empowered by this chapter to
6 issue permits, at one hundred (100), two hundred (200) or
7 three hundred (300) dollars. Such permit fee may be
8 graduated among the above amounts by such authority for
9 individual permit holders, based on the relative volume of
10 beer sales to the permit holder as shown by the records
11 required to be kept by section one hundred twenty-four point
12 twenty-seven (124.27), as against that of all other permit
13 holders during the next full prior calendar year within that
14 jurisdiction, but shall in no event be less than one hundred
15 (100) dollars."

EXPLANATION

The purpose of this bill is to permit charging a graduated fee for class "C" beer permits based upon volume of beer purchases, within the limitations established for class "B" beer permit fees.

- 1 Amend House File 364, Section 1, as follows:
2 1. By striking from line six (6) the words and figures "one
3 hundred (100), two hundred (200) or" and inserting in lieu
4 thereof the following: " fifty (50), one hundred fifty (150)
5 or".
6 2. By striking from lines fourteen (14) and fifteen (15)
7 the words and figures "one hundred (100)" and inserting in
8 lieu thereof the following "(50)".
