## A BILL FOR

An Act relating to the compensation of members of the budget and financial control committee.

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. Section two point forty-five (2.45), Code
- 2 1966, is hereby amended by striking from line six (6) the
- 3 word "thirty" and inserting in lieu thereof the word
- 4 "forty (40)".

### EXPLANATION

This bill will increase the per diem of the budget and financial control committee from \$30.00 to \$40.00. This will make the compensation consistent with the compensation established for their legislative duties while the joint assembly is in session.

- 4 By adding the following new section:
- 5 "Section two point fifty-one (2.51), Code 1966, is amended by

- 7 following: ', and shall receive a per diem of forty (40) dollars
- per
- 8 day for each day in attendance. However, members of the general
- 9 assembly shall not receive such per diem compensation for any day
- 10 during which the general assembly is in session. Such per diem
- 11 compensation shall be approved by the legislative research
- committee
- 12 prior to payment."
