A BILL FOR

An Act relating to juvenile delinquency.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section two hundred thirty-three point one
- 2 (233.1), Code 1966, is hereby amended by adding thereto the
- 3 following subsection:
- 4 "Willfully fail to support a minor child for whom one has
- 5 the legal obligation of support."

EXPLANATION

This bill would expedite the work of the County Attorney in collecting support moneys from one derelict in his duty to support a minor child.
