A BILL FOR

An Act to appropriate to the superintendent of public buildings and grounds from the general fund of the state of Iowa for capital improvements to the property known as the valley bank building located at Fourth and Walnut streets, city of Des Moines, Polk county, Iowa.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated from the general
2 fund of the state to the superintendent of public buildings and
3 grounds, the sum of one hundred thousand (100,000) dollars, or
4 so much thereof as may be necessary, for capital improvements
5 to the following described property, to wit:

6 East two-thirds (E 2/3) of lots five (5) and six (6),
7 block twenty-two (22), town of Fort Des Moines, now
8 included in and forming a part of the city of Des Moines,
9 Polk County, Iowa, together with the improvements thereon
10 and appurtenances thereto.

1 Sec. 2. Prior to any of the funds appropriated by this Act
2 being expended, the superintendent of public buildings and
3 grounds, with the approval of the state architect and the state
4 executive council, shall determine that the expenditure shall
5 be in the best interests of the state.

1 Sec. 3. Any unencumbered balance remaining as of June 30,
2 1971 of the funds appropriated by this Act shall revert to the
3 general fund of the state.

1 Sec. 4. This Act, being deemed of immediate importance,
2 shall be in full force and effect from and after its passage

3 and publication in _____, a newspaper pub-
4 lished at _____, Iowa, and in _____,
5 a newspaper published at _____, Iowa.

- 1 Amend House File 719 as follows:
2 1. By striking from line 3 of section 1 the words and figure
3 "one hundred thousand (100,000)" and by inserting in lieu thereof
4 the words and figure "fifty thousand (50,000)".
5 2. By adding the following new section:
6 "Sec. 4. The building above described shall be named 'The
7 Sullivan State Office Building' in honor of the five (5) Sullivan
8 brothers of Waterloo, Iowa who lost their lives on November 13,
9 1942, when the ship in which they were serving, the U.S.S. Juneau,
10 was sunk by enemy action in the Battle of Guadalcanal."

13 manner as a private individual. The tax due shall be paid by
14 the comptroller from the general fund out of any funds not other-
wise appropriated."
