A BILL FOR

An Act to appropriate from the general fund of the state of Iowa for capital improvements to the state fair board.

Conference Committee 7-1

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated from the general
2 fund of the state to the state fair board the sum of three
3 hundred fifty thousand (350,000) dollars, or so much thereof
4 as shall be necessary, to be used in the following manner:

5	For major repairs to buildings	\$ 150,000.00
6	For major repairs to or reconstruction	
7	of the women's building (family living	
8	center), the work to be done by state fair	
9	board employees or contracted for as deemed	
10	advisable by the state fair board and to	
11	be matched by equal funds of the state fair	
12	board	<u>200,000.00</u>
13	Total.	\$ 350,000.00

1 Sec. 2. Before any of the funds appropriated by this Act
2 shall be expended it shall be determined by the state fair board,
3 with the approval of the budget and financial control committee,
4 that the expenditures shall be for the best interests of the
5 state.

1 Sec. 3. Upon the completion of the projects as set forth
2 in this Act, any unobligated balance remaining may be used for
3 such other repairs or projects as needed.

1 Sec. 4. Any unencumbered balance remaining as of June 30,
2 1969 of the funds appropriated by this Act shall revert to
3 the general fund of the state as of June 30, 1969.

1 Amend House File 742 as follows:
2 By striking from line 6 of section 1 the words "major
3 repairs to or" and by striking from lines 8 and 9 of section
4 1 the words "the work to be done by state fair employees or"
5 and by inserting in lieu thereof the words "to be".
6 By striking from lines 3 and 4 of section 2 the words
7 "budget and financial control committee" and by inserting in
8 lieu thereof the words "executive council".

As Adopted by the Senate *House refused to concur 6-29, Senate insisted.*

2 1. Amend section one (1) by striking from line six (6) the
3 words "major repairs to or".
4 2. Further amend section one (1) by striking from lines
5 eight (8) and nine (9) the words "the work to be done by state
6 fair board employees or" and by inserting in lieu thereof the
7 words "to be".

REPORT OF CONFERENCE COMMITTEE ON HOUSE FILE 742

To the President of the Senate and the Speaker of the House of Representatives:

We, the undersigned members of the Conference Committee appointed to consider House File 742, a bill for an Act to appropriate from the general fund of the state of Iowa for capital improvements to the state fair board, begs leave to report and to make the following recommendation:

1. That House File 742 be amended as follows:

a. By striking from lines three (3) and four (4) of section two (2) the words "budget and financial control committee" and by inserting in lieu thereof the words "executive council".

b. By adding the following new section: "Sec. 5. This Act, being deemed of immediate importance shall be in full force and effect from and after its passage and publication as provided by law, in The Leon Journal-Reporter, a newspaper at Tripoli, Iowa."
