An Act to appropriate from the general fund of the state of Iowa to the department of public defense for various capital improvements and repairs, replacement, alteration, equipment, and rehabilitation purposes.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated from the general
2 fund of the state of Iowa to the department of public defense
3 the sum of two hundred thirty thousand (230,000) dollars, or
4 so much thereof as may be necessary, to be used in the follow-
5 ing manner:

6 1. For the state's share of the armory
7 construction program made available to the
8 state by the federal government for the
9 acquisition, construction, expansion, re-
10 habilitation, and converting facilities
11 of the administration and training units
12 of the national guard and state guard. \$ 20,000.00

13 2. For repairs, replacements, altera-
14 tions, equipment, and rehabilitation of
15 armories in connection with which federal
16 funds may be accepted. 80,000.00

17 3. For repairs, replacements, alterations,
18 equipment, and rehabilitation of grounds,
19 buildings, and roads at Camp Dodge, Iowa 75,000.00

20 4. For training facilities and support
21 including outside training area procurement,

22 rent, improvement, maintenance, and visual
 23 aids 55,000.00
 24 Total \$ 230,000.00

1 Sec. 2. Before any of the funds appropriated by this Act
 2 shall be expended, it shall be determined by the department of
 3 public defense, with the approval of the budget and financial
 4 control committee, that the expenditures shall be for the best
 5 interests of the state.

1 Sec. 3. Any unencumbered balance of funds appropriated by
 2 this Act remaining as of June 30, 1971 shall revert to the
 3 general fund of the state as of June 30, 1971.

1 Amend House File 750 by adding the following sections
 2 thereto:

3 "Sec. 4. This Act shall operate retroactively and retro-
 4 spectively, with full force and effect, to and from July 1,
 5 1967.

6 "Sec. 5. This Act, being deemed of immediate importance,
 7 shall take effect after its passage, approval and publication
 8 in the Clinton Herald, a newspaper published at Clinton,
 9 Iowa, and in the Le Mars Daily Sentinel, a newspaper
 10 published at Le Mars, Iowa.
