# A BILL FOR

An Act to appropriate from the general fund of the state of Iowa for the biennium beginning July 1, 1967 and ending June 30, 1969, funds for the central office of the state board of regents.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. There is hereby appropriated for the central  
2 office of the board of regents from the general fund of the  
3 state of Iowa for each year of the biennium beginning July 1,  
4 1967 and ending June 30, 1969, the sum of ninety-two thousand  
5 eight hundred ten (92,810) dollars, or so much thereof as may  
6 be necessary, to be used in the following manner:

7	For salary of chief administrative officer . . . . .	\$ 16,000.00
8	For other salaries . . . . .	49,340.00
9	For support, maintenance, and miscel-	
10	laneous (including board members receiving a	
11	perddiem of thirty (30) dollars per day not ex-	
12	ceeding nine thousand seven hundred twenty	
13	(9,720) dollars per year for all members) . . . . .	<u>27,470.00</u>
14	Grand total of all appropriations for all	
15	purposes for each year of the biennium for the	
16	central office of the state board of regents. . . . .	\$ 92,810.00

1 Sec. 2. All salaries provided for in this Act shall be  
2 payable in equal monthly or semi-monthly installments and  
3 shall be in full compensation for all services except as  
4 otherwise expressly provided and except further that expense  
5 allowances shall be authorized, any ruling of the Federal In-

6 ternal Revenue Service with respect to the tax status thereof  
7 notwithstanding.

1 Sec. 3. No employee of the central office of the board of  
2 regents shall receive salary or remuneration in excess of the  
3 salary fixed for the chief administrative officer.

1 Sec. 4. Chapter eight (8), Code 1966, shall apply to this  
2 Act.

1 Amend House File 762 as follows:
