A BILL FOR

An Act establishing a penalty for failure to file a semi-annual fertilizer tonnage report.

Be It Enacted by the General Assembly of the State of Iowa:

Section 1. Section two hundred point eight (200.8), Code 1966, is hereby amended by striking paragraph b of subsection two (2) of such section and inserting in lieu thereof the following:

"If the tonnage report is not filed or the payment of inspection fees, or both, is not made within ten (10) days after the date due, a penalty amounting to ten (10) percent of the amount due, if any, shall be assessed against the licensee. In any case, the penalty shall be no less than fifty (50) dollars. The amount of fees due, if any, and penalty shall constitute a debt and become the basis of a judgment against the licensee."
