## A BILL FOR

An Act relating to the State College of Iowa.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. Section two hundred sixty-eight point one  
2 (268.1), Code 1966, is hereby amended by striking from line  
3 three (3) the words, "State College of Iowa" and substituting  
4 the words, "Iowa Northern University".

1 Sec. 2. Wherever in the Code or in the Acts of the Sixty-  
2 second (62nd) General Assembly reference is made to the State  
3 College of Iowa, other than in this Act, said reference shall  
4 be construed to mean the Iowa Northern University and shall  
5 be changed to conform to the purposes of this Act and the  
6 code editor is directed to make the change.

1 Sec. 3. Section two hundred sixty-eight point two (268.2),  
2 Code 1966, is hereby repealed and the following is enacted  
3 in lieu thereof: "The university shall offer undergraduate  
4 and graduate courses of instruction, conduct research and  
5 provide extension and other public services in areas of its  
6 competence to facilitate the social, cultural and economic  
7 development of Iowa. Its primary responsibility shall be to  
8 prepare teachers and other educational personnel for schools,  
9 colleges, and universities and to carry out research and  
10 provide consultative and other services for the improvement  
11 of education throughout the state. In addition, it shall  
12 conduct programs of instruction, research and service in the  
13 liberal and vocational arts and sciences and offer such other

14 educational programs as the state board of regents may from  
15 time to time approve."

1 Sec. 4. Section two hundred sixty-eight point three  
2 (268.3), Code 1966, is hereby repealed.

21 1966, is hereby amended by striking from lines four (4) and  
22 five (5) of subsection eighteen (18) the words 'State College  
23 of Iowa' and inserting in lieu thereof the words 'University  
24 of Northern Iowa'.

25 "Sec. 6. Section ninety-seven B point forty-one (97B.41),  
26 Code 1966, is hereby amended by striking from subsection four-  
27 teen (14), paragraph d, lines six (6) and seven (7) the words  
28 'State College of Iowa' and inserting in lieu thereof the  
29 words 'University of Northern Iowa'.

30 "Sec. 7. Section one hundred forty-seven point thirty-one  
31 (147.31), Code 1966, is hereby amended by striking from lines  
32 eleven (11) and twelve (12) the words 'State College of Iowa'  
33 and inserting in lieu thereof the words 'University of  
34 Northern Iowa'.

35 "Sec. 8. Section two hundred sixty-two point seven  
36 (262.7), Code 1966, is hereby amended by striking subsection  
37 three (3) of such section and inserting in lieu thereof the  
38 following:

39 'The University of Northern Iowa.'

40 "Sec. 9. Section two hundred sixty-two point thirty  
41 (262.30), Code 1966, is hereby amended by striking from line
