A BILL FOR

An Act relating to the distribution of funds by the state comptroller.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section eight point six (8.6), Code 1966,
2 is hereby amended by adding to subsection two (2) the
3 following:

4 "Whenever the comptroller has funds that require dis-
5 tribution to counties, municipalities or other political
6 subdivisions of this state, he may partially distribute
7 such funds on a monthly basis. Whenever the Code requires
8 that any fund be paid by a specific date, the comptroller
9 shall prepare a final accounting and shall make a final
10 distribution of any remaining funds prior to that date."

1 Senate File 159 is hereby amended as follows:
2 Amend section one (1) by inserting in line six (6) after the
3 word "may" the words "upon determination that the recipient has
4 an emergency need for the funds".
