## A BILL FOR

An Act to provide for an additional agricultural producer association and including such an association in the agriculture marketing board.

*Be It Enacted by the General Assembly of the State of Iowa:*

Title nine (IX), Code 1966, is hereby amended by adding thereto the following new chapter consisting of sections one (1) and two (2) of this Act.

1 Section 1. The corporation known as the Iowa corn growers  
2 association incorporated under the laws of this state shall  
3 be entitled to the benefits of this chapter by filing each  
4 year with the department of agriculture verified proofs of  
5 its organization, names of its officers, and five hundred  
6 (500) persons who are bona fide members thereof together with  
7 such other information as the department may require.

1 Sec. 2. The Iowa corn growers association shall:

2 1. Aid the promotion of corn growers and the corn industry  
3 of Iowa through education, research, marketing, transportation  
4 study, and public relations programs, and to foster research  
5 designed to develop new additional and improved uses for corn  
6 products and determine better methods of converting them to  
7 various industrial and human uses.

8 2. Make an annual report of the proceedings to the secre-  
9 tary of agriculture.

1 Sec. 3. Section one hundred fifty-nine point twenty-five  
2 (159.25), Code 1966, is amended by inserting after the word  
3 "association" in lines fifteen (15) and sixteen (16) the words  
4 "Iowa corn growers association,".

5 Further amend said section by inserting in line thirty-three  
6 (33) after the word "association" the words "Iowa corn growers  
7 association,".

8 Further amend said section by striking from lines thirty-five  
9 (35) to forty (40) the words "However, in 1959 the appointees  
10 from the Iowa state dairy association, state horticulture  
11 society, and Iowa crop improvement association shall be selected  
12 as provided in this section and shall serve only until their  
13 successors are appointed and qualified in 1960." and insert in  
14 lieu thereof the words "However, in the year 1967 three (3)  
15 names shall be submitted by the Iowa corn growers association  
16 for a member to be appointed to the agriculture marketing board  
17 for a term of three (3) years ending July 1, 1970."

- 6 of section 3.
