# A BILL FOR

An Act to make appropriations to certain named persons or firms in settlement of claims made against the state of Iowa.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is appropriated out of the general fund  
2 of the state of Iowa, to the following named persons or firms  
3 the amount set opposite their respective names in full settle-  
4 ment of all claims which they may have against the state of  
5 Iowa, to wit:

6	Dean G. Parrott .....	\$ 306.20
7	Petersen-Stanton Court Reporters .....	4,142.75
8	Robert J. Cassel .....	260.01
9	James, Greer and Nelson .....	3,942.08
10	Robinson and Robinson .....	1,065.00

1 Sec. 2. The state comptroller is hereby authorized and  
2 directed to issue his warrant to the above named persons or  
3 firms in the amounts set opposite their names, and the trea-  
4 surer of the state is hereby authorized and directed to pay  
5 the same from the general fund of the state of Iowa.

1 Sec. 3. Receipt of said sums by said persons or firms shall  
be in full settlement of all claims they may hold against the  
3 state of Iowa.

1 Sec. 4. This Act, being deemed of immediate importance,  
2 shall take effect and be in force from and after its publica-  
3 tion in the Mount Ayr Record-News, a newspaper published in  
4 Mount Ayr, Iowa, and in The Spencer Daily Reporter, a newspaper  
5 published in Spencer, Iowa.

1 Amend Senate File 338, Section 1 line 9 by striking the figures  
2 three thousand nine hundred forty two dollars and eight cents  
3 (\$3,942.08) and inserting in lieu thereof the figures three  
4 thousand thirty five dollars and eight cents (\$3,035.08).  
5 Further amend Senate File 338, Section 1 line 10 by striking  
6 the  
7 figures one thousand sixty five dollars (\$1,065.00) and inserting  
in lieu thereof the figures eight hundred forty dollars (\$840.00).
