## A BILL FOR

An Act to permit county boards of supervisors to provide ambulance service.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section three hundred thirty-two point  
2 three (332.3), Code 1966, is hereby amended by adding  
3 thereto the following new subsection.

4 "To purchase, lease, equip, maintain and operate an  
5 ambulance or ambulances to provide necessary and sufficient  
6 ambulance service or to contract for such vehicles, equipment,  
7 maintenance or service."

- 1 Amend Senate File 51 by adding the following:
- 2 "Sec. 2. This Act, being deemed of immediate importance,
- 3 shall take effect and be in force from and after its publi-
- 4 cation in the New Hampton Tribune, a newspaper published
- 5 in New Hampton, Iowa, and in The Times Plain Dealer, a news-
- 6 paper published in Cresco, Iowa."
