A BILL FOR

An Act to amend chapter three hundred seventy (370), Code 1966,
relating to the control of municipal recreational facilities.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Chapter three hundred seventy (370), Code 1966,
 2 is hereby amended by adding at the end thereof the following
 3 new section:
 4 "The board of park commissioners and the city or town council
 5 of any city or town may by resolution agree that the city or
 6 town council of said city or town shall have exclusive control
 7 over any swimming pool or golf course, the construction of which
 8 is financed in whole or in part by means of the issuance of
 9 bonds of said city or town payable from the revenues derived
 10 from the operation of such swimming pool or golf course for a
 11 period not to exceed forty (40) years, whether such swimming
 12 pool or golf course is located on land owned by said city or
 13 town or on land held in the name of said board of park commis-
 14 sioners, either within or without the corporate limits of said
 15 city or town, if said board of park commissioners and said
 16 city or town council determine that such exclusive control by
 17 said city or town council will facilitate the orderly operation
 18 of such swimming pool or golf course and the efficient manage-
 19 ment of the revenues derived from the operation thereof, any
 20 other statute to the contrary notwithstanding."
 1 Sec. 2. This Act being of immediate importance shall be in
 2 full force and effect from and after its passage and publication
