## A BILL FOR

An Act relating to the fees of licenses issued by the state conservation commission.

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. Section one hundred ten point one (110.1), Code  
2 1966, is hereby amended as follows:
- 3 1. By striking from line twenty-seven (27) the figure "3.00"  
4 and inserting in lieu thereof the figure "4.00".
- 5 2. By striking from line thirty (30) the figure "5.00" and  
6 inserting in lieu thereof the figure "6.00".
- 7 3. By striking lines thirty-one (31) through forty-four (44)  
8 and inserting in lieu thereof the following:  
9 "Hunting license for nonresident or alien..... 20.00".
- 10 4. By inserting after line forty-six (46) the following:  
11 "Fishing license (resident and nonresident):  
12 One-day license for resident, nonresident, or alien.....  
13 1.00".
- 14 5. By striking lines fifty-one (51) through sixty-three (63)  
15 and inserting in lieu thereof the following:  
16 "Fishing license for nonresident or alien..... 5.00".
- 17 6. By striking from line sixty-four (64) the figure "2.00"  
18 and inserting in lieu thereof the figure "10.00".
- 19 7. By striking lines sixty-nine (69) through eighty-two (82)  
20 and inserting in lieu thereof the following:  
21 "Trapping license for nonresident or alien..... 100.00".
- 22 8. By striking from line eighty-three (83) the figure "10.00"

23 and inserting in lieu thereof the figure "25.00".

24 9. By striking lines eighty-four (84) through ninety-eight (98)  
25 and inserting in lieu thereof the following:

26 "Nonresident fur dealer's license..... 150.00".

27 10. By striking lines one hundred fourteen (114) through one  
28 hundred thirty (130) and inserting in lieu thereof the following:

29 "All nets not otherwise provided for, each net..... 3.00".

30 11. By striking lines one hundred thirty-two (132) and one  
31 hundred thirty-three (133) and inserting in lieu thereof the  
32 following:

33 "For each trap..... 1.00".

34 12. By striking lines one hundred thirty-five (135) and one  
35 hundred thirty-six (136) and inserting in lieu thereof the follow-  
36 ing:

37 "For each trotline..... 1.00".

38 13. By striking lines one hundred fifty-nine (159) through one  
39 hundred seventy (170) and inserting in lieu thereof the following:

40 "All nets not otherwise provided for, each net..... 3.00".

41 14. By striking lines one hundred seventy-two (172) through one  
42 hundred seventy-three (173) and inserting in lieu thereof the follow-  
43 ing:

44 "For each trap..... 3.00".

45 15. By striking lines one hundred seventy-four (174) through one  
46 hundred seventy-six (176).

47 16. By striking lines one hundred seventy-eight (178) and one  
48 hundred seventy-nine (179) and inserting in lieu thereof the follow-  
49 ing:

50 "For each trotline..... 4.00".

51 17. By striking from line one hundred eighty-one (181) the  
52 figure "2.00" and inserting in lieu thereof the figure "10.00".

53 18. By striking lines one hundred eighty-two (182) through one  
54 hundred ninety-five (195) and inserting in lieu thereof the follow-  
55 ing:

56 "Nonresidents or aliens..... 25.00".

57 19. By striking line one hundred ninety-seven (197) and in-  
58 serting in lieu thereof the following:

59 "licenses:

60 "Legal residents..... 10.00

61 "Wholesale fish-market license:

62 "Nonresident or alien..... 25.00

63 "Wholesale fish-peddlers license:

64 "Nonresident or alien..... 10.00".

65 20. By striking from line two hundred one (201) the figure  
66 "2.00" and inserting in lieu thereof the figure "10.00".

67 21. By striking line two hundred two (202) and inserting in  
68 lieu thereof the following:

69 "Bait dealer's licenses:

70 "Legal residents..... 25.00

71 "Nonresidents or aliens.... 50.00".

72 22. By striking therefrom lines two hundred three (203) and  
73 two hundred four (204).

3 "By inserting the following new paragraph after line  
4 thirty (30):  
5 'Iowa residents who have reached the age of sixty-five  
6 (65) years:  
7 'For any fishing license, special trout fishing license  
8 stamp, hunting license, or hunting and fishing combined  
9 license required by the foregoing provisions of this section,  
10 the fee for any resident of the state who has reached the age  
11 of sixty-five (65) years before purchasing the license shall  
12 be one-half (1/2) of the amount herein provided.'"
