A BILL FOR

An Act relating to the availability of the report of the investigating law enforcement officer.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section three hundred twenty-one point two hun-
2 dred seventy-one (321.271), Code 1966, is hereby repealed and
3 the following enacted in lieu thereof:

4 "All accident reports filed by a driver of a vehicle involved
5 in an accident as required under section three hundred twenty-
6 one point two hundred sixty-six (321.266) of the Code shall be
7 in writing. The report shall be without prejudice to the indi-
8 vidual so reporting and shall be for the confidential use of
9 the department, except that upon the request of any person
10 involved in the accident, or the attorney for such person, the
11 department shall disclose the identity and address of the per-
12 son involved in the accident. The written report filed with
13 the department shall not be admissible in or used in evidence in
14 any civil case arising out of the facts on which the report is
15 based.

16 "All written reports filed by a law enforcement officer as
17 required under section three hundred twenty-one point two hun-
18 dred sixty-six (321.266) shall be made available to any party
19 to an accident or his attorney on written request to the depart-
20 ment of public safety and the payment of a fee of one (1) dollar
21 for each copy."
