A BILL FOR

An Act to establish a state department of social services, combining the present functions of the board of social welfare, department of social welfare, board of parole, board of control of state institutions and other state agencies and divisions.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby established a department of
2 social services to administer programs designed to improve
3 the well-being and productivity of the people of the state
4 of Iowa. The department shall concern itself with the prob-
5 lems of human behavior, adjustment and daily living through
6 the administration of programs of family, child and adult
7 welfare, economic assistance (including costs of medical care),
8 rehabilitation toward self-care and support, delinquency pre-
9 vention and control, treatment and rehabilitation of adult
10 and juvenile offenders, care and treatment of the mentally
11 ill and mentally retarded, and other related programs as pro-
12 vided by law.

1 Sec. 2. There is hereby established the council of social
2 services. All of the public members of the board of control
3 and board of social welfare, shall, initially, comprise the
4 council of social services. All such initial members shall
5 serve thereon until the term to which they were appointed to
6 either the board of control or board of social welfare shall
7 expire. Upon the first expiration of the term of any member
8 thereof, no new appointment shall be made. Thereafter, the

9 council shall consist of five (5) members. Upon the expira-
10 tion of the term of each succeeding member thereof, the gover-
11 nor, with the approval and confirmation of two-thirds (2/3)
12 of the senate, shall appoint a new member thereto for a term
13 of six (6) years commencing on July 1 of the year of appoint-
14 ment. All members of the council shall be electors of the
15 state of Iowa. No more than three (3) such members shall
16 belong to the same political party and no two (2) such members
17 shall, at the time of appointment, reside in the same congres-
18 sional district. Vacancies occurring during a term of office
19 shall be filled in the same manner as the original appoint-
20 ment for the balance of the unexpired term subject to con-
21 firmation by two-thirds (2/3) of the senate within sixty (60)
22 days of convening at its next regular session.

1 Sec. 3. The governor shall initially appoint one (1) mem-
2 ber of the council as chairman and one (1) member as vice
3 chairman. He shall thereafter upon the expiration of the
4 term of the chairman and vice chairman so appointed, appoint
5 a new chairman and vice chairman.

1 Sec. 4. The council of social services shall:

2 1. Adopt rules and regulations for the conduct of its
3 meetings.

4 2. Adopt and establish policy for the operation and con-
5 duct of the department of social services and the implementa-
6 tion of all services and programs thereunder.

7 3. Report immediately to the governor any failure by the
8 commissioner or any director of the department of social ser-
9 vices to carry out any of the policy decisions or directives
10 of the council.

11 4. Hear and determine all appeals as provided by law.
12 The council may affirm, modify or reverse any decision on
13 appeal.

14 5. Approve the budget of the department of social services
15 prior to submission to the governor.

16 6. Insure that all programs administered or services

17 rendered by the department directly to any citizen or through
18 a local board of welfare to any citizen are coordinated and
19 intergrated so that any citizen does not receive a duplica-
20 tion of services from various departments or local agencies
21 that could be rendered by one (1) department or local agency.
22 If the council finds that such is not the case, it shall hear
23 and determine which department or local agency shall provide
24 the needed service or services and enter an order of their
25 determination by resolution of the council which must be con-
26 curred in by at least a majority of the members. Thereafter
27 such order or resolution of the council shall be obeyed by all
28 state departments of local agencies to which it is directed.

29 7. Conduct research in improved methods and programs to
30 promote social services in this state.

31 8. Disseminate information pertaining to the various pro-
32 grams of social service to residents of the state of Iowa.

33 9. Approve all necessary rules and regulations adopted by
34 the commissioner prior to their promulgation pursuant to chap-
35 ter seventeen A (17A) of the Code.

36 10. Approve the establishment of any new department or re-
37 organization, consolidation or abolition of any established
38 department prior to the same becoming effective.

1 Sec. 5. The council shall meet four (4) times a year.
2 Special meetings shall be called by the chairman or upon writ-
3 ten request of any three (3) members thereof. The chairman
4 shall preside at all meetings or in his absence the vice
5 chairman shall preside. The members of the council shall be
6 paid a per diem of forty (40) dollars per day while in session,
7 ten (10) cents a mile for travel, and their reasonable and
8 necessary expenses while attending such meetings.

1 Sec. 6. All powers heretofore exercised by the board of
2 control of state institutions and the board of social welfare
3 and department of social welfare are hereby transferred to
4 and shall hereafter be possessed by the department of social
5 services or the council of social services. All duties, func-

6 tions and programs heretofore imposed upon or charged to the
7 board of control of state institutions, the board of social
8 welfare and department of social welfare are hereby trans-
9 ferred to and shall hereafter be imposed upon or charged to
10 the department of social services.

1 Sec. 7. This Act and the transfer herein shall be effec-
2 tive January 1, 1968. The governor may appoint the commis-
3 sioner and director of the major divisions thereof prior to such
4 date in order to insure an orderly transfer of responsibilities.

1 Sec. 8. There shall be a commissioner of social services
2 who shall be the chief administrative officer for the depart-
3 ment of social services. He shall be appointed by the gover-
4 nor to serve at his pleasure.

1 Sec. 9. The commissioner is hereby authorized to adopt and
2 promulgate, pursuant to chapter seventeen A (17A) of the Code,
3 such rules and regulations as are necessary to carry into
4 practice the programs of the various divisions and to es-
5 tablish such divisions, all with the approval of the council
6 of social services, within his department as he deems neces-
7 sary and appropriate for the proper administration of the
8 duties, functions and programs with which the department is
9 charged. Any action taken, decision made, or administrative
10 rule adopted by any director of a division may be reviewed by
11 the commissioner. The commissioner, upon such review, may
12 affirm, modify, or reverse any such action, decision, or rule.

13 The department of social services shall be initially
14 divided into the following divisions of responsibility: the
15 division of child and family services, the division of mental
16 health, the division of administration, the division of cor-
17 rections and the division of planning, research and statistics.

1 Sec. 10. The commissioner shall appoint a director of each
2 of the aforementioned divisions. Such directors shall be
3 selected on the basis of their particular professional quali-
4 fications, education and background relative to the intended
5 assigned responsibilities of their division.

1 Sec. 11. The director of the division of child and family

2 services shall be qualified by training, experience and educa-
3 tion in the field of welfare and social problems. He shall be
4 entrusted with the administration of programs involving neglec-
5 ted, dependent and delinquent children, child welfare, aid to
6 dependent children, aid to disabled persons and shall administer
7 and be in control of the Iowa Juvenile Home, The Annie Wittenmyer
8 Home, the State Juvenile Home, the State Training School for
9 Boys and for Girls, the Iowa Soldiers Home and such other re-
10 lated programs established for the general welfare of families,
11 adults and children as directed by the commissioner.

1 Sec. 12. The director of the division of child and family
2 services shall have the additional following duties, powers
3 and responsibilities:

4 1. Develop a program of basic education, recreation, voca-
5 tional training and guidance for social adjustment.

6 2. Administer programs and statutes involved with child
7 placement, employment and supervision of state boards.

8 3. Prepare a budget and such report or reports as required
9 by law or as directed by the commissioner.

10 4. Develop a program in corrective institutions for juve-
11 niles designed to rehabilitate the inmates and patients and
12 institute a program of placement and parole supervision for
13 all parolees of said corrective institutions for juveniles.

1 Sec. 13. The director of the division of mental health
2 shall be a qualified psychiatrist. He shall be admitted to
3 the practice of medicine in this state and shall have at
4 least five (5) years of actual experience in the care and
5 treatment of persons afflicted with mental disease and three
6 (3) years actual experience in institutional administration.
7 He shall hold a certificate of qualifications in psychiatry
8 issued by the American Board of Psychiatry and Neurology.

1 Sec. 14. He shall be responsible for and in control of
2 the administration of institutions and programs regarding the
3 care, treatment and supervision of the mentally ill and the
4 mentally retarded and in particular shall be in control of and
5 administer and supervise the following state institutions:

6 the Mount Pleasant Health Institute, the Independence Mental
7 Health Institute, the Cherokee Mental Health Institute, the
8 Clarinda Mental Health Institute and the Glenwood and Woodward
9 State Schools and Hospitals. He shall also carry out such
10 other functions and duties as may be delegated to him by the
11 commissioner of social services.

1 Sec. 15. The director of the division of mental health
2 shall also have the following additional powers, duties and
3 responsibilities:

4 1. Establish psychiatric services for all institutions
5 under the control of the commissioner of the department of
6 social services in order that patients in such institutions
7 shall receive the psychiatric services that are necessary and
8 proper.

9 2. Appoint professional consultants who shall furnish
10 advice on all matters pertaining to mental health. Such con-
11 sultants shall be paid as provided by an appropriation of the
12 general assembly.

13 3. Act as compact administrator with power to effectuate
14 the purposes of and make necessary rules to implement inter-
15 state compacts on mental health.

16 4. Examine or cause to be examined by an assistant all
17 public and private institutions receiving and caring for the
18 mentally ill, mentally retarded and epileptics to determine
19 their efficiency for adequate care and treatment of their
20 patients.

21 5. Insure that the purposes of mental hospitals are carried
22 into effect and to that end shall have all necessary powers
23 not inconsistent with law.

24 6. Establish and supervise suitable standards of treat-
25 ment and care of patients in all state hospitals for the
26 mentally ill, mentally retarded and epileptic.

27 7. Establish the qualifications of all officers, physi-
28 cians, nurses, attendants and other employees responsible for
29 the care and treatment of patients.

30 8. Prepare a budget and such report or reports as requir-
31 ed by law or as directed by the commissioner.

1 Sec. 16. The director of the division of corrections shall
2 be qualified in reformatory and prison management with special
3 training in sociology and psychology. He shall also have
4 practical experience in the field of criminology and disci-
5 pline and in the supervision of inmates in corrective penal
6 institutions.

1 Sec. 17. The director of the division of corrections
2 shall have the following powers, duties and responsibilities:

3 1. Administer and control the operation of the Men's Re-
4 formatory, Women's Reformatory and State Penitentiary.

5 2. Supervision and control over all state agents provided
6 for in chapter two hundred eighteen (218) of the Code.

7 3. Establishment and maintenance of acceptable standards
8 of treatment, training, education and rehabilitation in the
9 various state penal and corrective institutions.

10 4. Examination of all state institutions which are penal,
11 reformatory or corrective to determine their efficiency for
12 adequate care, custody and training of their inmates and
13 report his findings and conclusions to the commissioner of
14 the department of social services. He shall inquire into and
15 determine the qualifications of wardens, matrons, superinten-
16 dents, officers, attendants, guards and other employees res-
17 ponsible for the care, custody, training, discipline and
18 rehabilitation of inmates and make recommendations to the
19 commissioner regarding same.

20 5. Preparation of a budget and such other reports as
21 required by law or as directed by the commissioner.

22 6. Supervise all persons placed on parole by the parole
23 board and develop and administer such additional programs of
24 rehabilitation for persons on parole as will insure their
25 adjustment to society.

1 Sec. 18. The director of the division of administration
2 shall be qualified in the general field of governmental ad-

3 ministration with special training and experience in the areas
4 of competitive bidding, contract letting, accounting and bud-
5 get preparation.

1 Sec. 19. The director of the division of administration
2 shall cooperate with the directors of the other divisions of
3 the department of social services, assist them and the commis-
4 sioner of the department in the preparation of their and his
5 annual budgets and such other like reports as may be request-
6 ed by the commissioner or required by law.

1 Sec. 20. The director of the division of planning,
2 research and statistics shall be qualified in the general
3 field of governmental planning with special training and
4 experience in the areas of preparation and development of
5 plans for future efficient reorganization and administration
6 of government social functions. The director of the divi-
7 sion of planning, research and statistics shall cooperate
8 with the directors of the other divisions of the department
9 of social services assisting them and the commissioner of the
10 department in their planning, research and statistical prob-
11 lems. He shall assist the directors, commissioner and the
12 council of social services by proposing administrative and
13 organizational changes at both the state and local level to
14 provide more efficient and integrated social services to the
15 citizens of this state. The planning, research and
16 statistical operations now forming an integral part of the
17 present state functions assigned to the directors of this
18 department along with their future needs in this regard
19 are hereby all assigned to and shall be administered by
20 the director of this division.

1 Sec. 21. Section eight point five (8.5), Code 1966, is
2 hereby amended by striking from lines five (5) and six (6)
3 of paragraph c of subsection six (6) the words "board of
4 control or employees in institutions under the board of
5 control" and by inserting in lieu thereof the words "insti-

6 tutions controlled by any director of a division of the
7 department of social services".

2 teen (19), Code 1966, is hereby amended as follows:

3 1. By striking from lines three (3) and four (4) the
4 words "state board of control" and by inserting in lieu

15 "Such rules when prescribed or approved by the directors
16 shall be uniform and shall apply to all institutions under
17 the particular director and to all other institutions under
18 his jurisdiction and the primary rules of the director of the
19 division of mental health for use in institutions where the
20 mentally ill are kept shall, unless otherwise indicated, uni-
21 formly apply to county or private hospitals wherein the men-
22 tally ill are kept, but such rules shall not interfere with
23 proper medical treatment administered patients by competent
24 physicians. Annually, signed copies of such rules shall be
25 sent to the chief executive officer of each such institution
26 or hospital under the control or supervision of a particular
27 director and copies shall also be sent to the clerk of each
28 district court, the chairman of the board of supervisors of
29 each county and, as appropriate, to the officer in charge of
30 institutions or hospitals caring for the mentally ill in each
31 county who shall be responsible for seeing that the same is
32 posted in each institution or hospital in a prominent place.

33 Such rules shall be kept current to meet the public need and
34 shall be revised and published annually.

35 "The state fire marshall shall cause to be made an annual
36 inspection of all the institutions listed in section two hun-
37 dred eighteen point one (218.1) of the Code and shall make
38 written report thereof to the particular director of the state
39 department of social services in control of such institution."
