# A BILL FOR

An Act to appropriate from the general fund of the state of Iowa for the biennium beginning July 1, 1967 and ending June 30, 1969 to the office of the superintendent of public buildings and grounds for operational costs of the property known as the valley bank building located at fourth and walnut streets, city of Des Moines, Polk county, Iowa.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. There is hereby appropriated from the general  
2 fund of the state of Iowa for each year of the biennium be-  
3 ginning July 1, 1967 and ending June 30, 1969 to the superin-  
4 tendent of public buildings and grounds the sum of one hundred  
5 ten thousand five hundred (110,500) dollars, or so much thereof  
6 as may be necessary, to be used in the following manner:

7 For salaries . . . . . \$ 80,000.00  
8 For support, maintenance, and  
9 miscellaneous purposes . . . . . 30,500.00

10 Grand total of all appropriations for all  
11 purposes for each year of the biennium for  
12 the superintendent of public buildings and  
13 grounds provided by this Act . . . . . \$ 110,500.00
