A BILL FOR

An Act relating to the compensation and expenses of the members of the commission of hospitalization.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section two hundred twenty-eight point nine
2 (228.9), Code 1966, is hereby amended by striking all of sub-
3 sections one (1) and two (2) of such section and inserting in
4 lieu thereof the following:

5 "1. The compensation and expenses of the members of the
6 commission shall be fixed by the judge of the district court
7 in the judicial district where the hearing is held. This com-
8 pensation shall be in addition to any compensation now allowed
9 by law.

10 "2. The compensation of the examining physician shall be
11 fixed by the judge of the district court in the judicial dis-
12 trict where the hearing is held."
