A BILL FOR

1 An Act relating to fees collected on the county level of
2 government.

3 *Be It Enacted by the General Assembly of the State of Iowa:*

4 Section 1. Section three hundred thirty-three point fifteen
5 (883.15), Code 1966, is hereby amended as follows:

6 1. By striking from subsection one (1), line two (2), the
7 words "fifty cents" and inserting in lieu thereof the words "two
8 dollars".

9 2. By striking from subsection one (1), line nine (9), the
10 words "two and one-half" and inserting in lieu thereof the word
11 "ten".

12 3. By striking from subsection two (2), line two (2), the
13 words "fifty cents" and inserting in lieu thereof the words "two
14 dollars".

15 4. By striking from subsection three (3), line three (3)
16 the words "fifty cents" and inserting in lieu thereof the words
17 "two dollars".

18 Sec. 2. Section five hundred fifty-eight point fifty-seven
19 (558.57), Code 1966, is hereby amended by striking from line
20 eleven (11) the figures "50c" and inserting in lieu thereof the
21 words "two dollars".

22 Sec. 3. Section five hundred fifty-eight point sixty-six
23 (558.66), Code 1966, is hereby amended by striking from line
24 seven (7) the words "fifty cents" and inserting in lieu thereof
25 the words "two dollars".

EXPLANATION

This bill will increase the fee for real estate transfers, certificates of redemption, and certificates for lands sold for nonpayment of taxes from 50 cents to \$2. This increase is designed to make these duties of the county auditor more self-supporting.

- 1 Amend House File 1018 as follows:
- 2 1. Lines 7 and 8, by striking the words "two dollars"
- 3 and inserting in lieu thereof the words "one dollar".
- 4 2. Line 11 by striking the word "ten" and inserting
- 5 in lieu thereof the word "five".
- 6 3. Line 13, and 14, by striking the words "two dollars"
- 7 and inserting in lieu thereof the words "one dollar".
- 8 4. Line 17 by striking the words "two dollars" and
- 9 inserting in lieu thereof the words "one dollar".
- 10 5. Line 21, by striking the word "two dollars" and
- 11 inserting in lieu thereof the words "one dollar".
- 12 6. Line 25, by striking the words "two dollars" and
- 13 inserting in lieu thereof the words "one dollar".
