A BILL FOR

- 1 An Act to legalize and validate the proceedings of the board
- 2 of supervisors of Mitchell county, Iowa, authorizing and
- 3 providing for the issuance of county public hospital bonds
- 4 and for the levy of taxes for the payment of said bonds
- 5 and declaring the bonds issued pursuant to said proceedings
- 6 to be enforceable obligations of said county.
- 7 WHEREAS, it appears from the records of the board of
- 8 supervisors of Mitchell county, Iowa, that at a special
- 9 election held in and for said county on December 29, 1969,
- 10 the proposition of issuing bonds of said county in the sum
- 11 of nine hundred five thousand dollars for the purpose of
- 12 erecting and equipping an addition to the existing county
- 13 public hospital was approved by more than sixty per cent of
- 14 the total number of votes cast for and against said proposition,
- 15 and in reliance upon said election said board of supervisors
- 16 thereafter authorized and provided for the issuance and
- 17 sale of county public hospital bonds to the amount and for the
- 18 purpose aforesaid and made provision for the levy of taxes
- 19 sufficient to pay said bonds and the interest thereon; and
- 20 WHEREAS, doubts have arisen concerning the validity and
- 21 legal sufficiency of said election and proceedings and pro-
- 22 visions made for the issuance and payment of said bonds and
- 23 it is deemed advisable to put such doubts and all others
- 24 that might arise concerning same forever at rest; NOW, THERE-
- 25 FORE,

1 *Be It Enacted by the General Assembly of the State of Iowa:*

2 Section 1. That all proceedings heretofore taken by the
3 board of supervisors of Mitchell county, Iowa, preliminary
4 to and in connection with the election on said bonds held
5 in said county on December 29, 1969, and providing for the
6 issuance, sale and delivery of county public hospital bonds
7 of said county in the amount of nine hundred five thousand
8 dollars pursuant to said election, and for the levy of taxes
9 sufficient to pay said bonds and interest thereon, are hereby
10 legalized, validated and confirmed and said county public
11 hospital bonds issued, sold and delivered pursuant to and
12 in accordance with said proceedings are hereby declared to
13 be legal and to constitute the valid and binding obligations
14 of said county.

15 Section 2. This Act being of immediate importance shall
16 be in full force and effect from and after its passage and
17 publication in the Mitchell County Press-News, a newspaper
18 published at Osage, Iowa, and the Eclipse News Review,
19 a newspaper published at Parkersburg, Iowa, with-
20 out expense to the state.

EXPLANATION

This Act validates proceedings by which the Board of Supervisors of Mitchell county, Iowa, issued county public hospital bonds and levied taxes for the payment thereof.
