A BILL FOR

- 1 An Act to legalize and validate the proceedings of the board
- 2 of directors of the Oelwein Community School District, in
- 3 the Counties of Fayette and Buchanan, State of Iowa,
- 4 authorizing and providing for the sale and issuance of
- 5 school building bonds and for the levy of taxes for the
- 6 payment of said bonds and declaring the bonds issued
- 7 pursuant to said proceedings to be enforceable obligations
- 8 of said school district.
- 9 WHEREAS, it appears from the records of the board of directors
- 10 of the Oelwein Community School District, in the Counties of
- 11 Fayette and Buchanan, State of Iowa, that at a special school
- 12 election held in and for said school district on May 15, 1969,
- 13 the proposition of issuing bonds of said school district in the
- 14 amount of one million six hundred thousand dollars for the pur-
- 15 pose of carrying out a school building program consisting of
- 16 building and furnishing a new elementary school building and a
- 17 new junior high school building and procuring sites for new
- 18 school buildings was approved by more than sixty per cent of
- 19 the total number of votes cast for and against said proposition,
- 20 and in reliance upon said election said board of directors
- 21 thereafter authorized and provided for the sale and issuance of
- 22 school building bonds to the amount and for the purpose aforesaid
- 23 and made provision for the levy of taxes to pay said bonds and
- 24 the interest thereon; and
- 25 WHEREAS, doubts have arisen concerning the validity and legal

1 sufficiency of said election and proceedings and provisions
2 made for the issuance and payment of said bonds and it is
3 deemed advisable to put such doubts and all others that might
4 arise concerning same forever at rest; NOW THEREFORE,
5 *Be It Enacted by the General Assembly of the State of Iowa:*
6 Section 1. That all proceedings heretofore taken by the
7 board of directors of the Oelwein Community School District,
8 in the Counties of Fayette and Buchanan, State of Iowa, pre-
9 liminary to and in connection with the election on said bonds
10 held in said school district on May 15, 1969, and providing for
11 the sale, issuance and delivery of school building bonds of
12 said school district in the amount of one million six hundred
13 thousand dollars pursuant to said election, and for the levy
14 of taxes to pay said bonds and interest thereon, are hereby
15 legalized, validated and confirmed and said school building
16 bonds issued, sold and delivered pursuant to and in accordance
17 with said proceedings are hereby declared to be legal and to
18 constitute the valid and binding obligations of said school
19 district.
20 Section 2. This Act being of immediate importance shall be
21 in full force and effect from and after its passage and publi-
22 cation in the Independence Conservative, a newspaper published
23 at Independence, Iowa, and the Oelwein Daily Register, a news-
24 paper published at Oelwein, Iowa, without expense to the state.

EXPLANATION

This Act validates proceedings whereby the Oelwein Community School District board of directors issued school building bonds pursuant to an election authorizing the same and provided for the levy of taxes to pay for said bonds.
