- 5 Section 1. There is hereby appropriated out of the general
- 6 fund of the state of Iowa to the following named persons and

16 the state of Iowa, as above indicated, claims for which were pre-
17 sented to the joint claims committee of the Sixty-third General
18 Assembly.
