## A BILL FOR

1 An Act to legalize and validate the proceedings of the Board  
2 of Directors of the Bondurant-Farrar Community School  
3 District, in the Counties of Jasper and Polk, State of  
4 Iowa, in connection with an election for the issuance of  
5 school bonds and declaring the validity of said election  
6 and that bonds issued pursuant to and authorized thereby  
7 shall constitute valid and binding obligations of said  
8 School District.  
9 WHEREAS, it appears from the records of the Board of Di-  
10 rectors of the Bondurant-Farrar Community School District, in  
11 the Counties of Jasper and Polk, State of Iowa, that at a  
12 special school election held in and for said School District  
13 on December 16, 1968, the proposition of issuing bonds of  
14 said School District in the amount of Four Hundred Fifty  
15 Thousand Dollars for the purpose of remodeling an existing  
16 school building at Bondurant and building and furnishing an  
17 addition thereto, and remodeling an existing school building  
18 at Farrar, was approved by more than sixty per cent of the  
19 total number of votes cast for and against said proposition,  
20 and in reliance upon said election said Board of Directors  
21 proposes to authorize and provide for the issuance of school  
22 bonds to the amount and for the purpose aforesaid; and  
23 WHEREAS, doubts have arisen concerning the validity and  
24 legal sufficiency of said election and it is deemed advisable  
25 to put such doubts and all others that might arise concerning

1 the same forever at rest; NOW, THEREFORE,

2 *Be It Enacted by the General Assembly of the State of Iowa:*

3 Section 1. All proceedings heretofore taken by the Board  
4 of directors of the Bondurant-Farrar Community School Dis-  
5 trict, in the counties of Jasper and Polk, State of Iowa,  
6 preliminary to and in connection with the election on said  
7 bonds held in said School District on December 16, 1968, and  
8 said election, are hereby legalized, validated and confirmed  
9 and school bonds to be issued, sold and delivered pursuant to  
10 and by authority of said election shall constitute valid and  
11 binding obligations of said School District.

12 Sec. 2. This Act, being of immediate importance, shall  
13 be in full force and effect from and after its passage, ap-  
14 proval and publication in The Colfax Tribune, a newspaper  
15 published at Colfax, Iowa, and in The Altoona Herald, a news-  
16 paper published at Altoona, Iowa, without expense to the  
17 State.

#### EXPLANATION OF HOUSE FILE 243

This bill legalizes the proceedings of the Bondurant-Farrar Community School District in the counties of Polk and Jasper, whereby on December 16, 1968, a special election was held for the purpose of issuing school bonds in order to finance the remodeling of certain school buildings.
