## A BILL FOR

1 An Act to appropriate administration and educational and  
2 training aid funds from the general fund of the state  
3 to the department of public instruction for the biennium  
4 beginning July 1, 1969 and ending June 30, 1971.

5 *Be It Enacted by the General Assembly of the State of Iowa:*

6 Section 1. There is hereby appropriated from the general  
7 fund of the state to the department of public instruction  
8 for each year of the biennium beginning July 1, 1969 and end-  
9 ing June 30, 1971, the following amounts, or so much thereof  
10 as may be necessary, to be used for the purposes designated:

11 1. NATIONAL DEFENSE EDUCATION

12 For the purpose of accepting federal funds currently re-  
13 ferred to as the national defense education act of 1958, as  
14 amended, for (a) administration and extension of supervisory  
15 and related services by the department for financial assistance  
16 for strengthening sciences, mathematics, modern foreign  
17 language instruction and other critical subjects; (b) ad-  
18 ministration by the department and the several school districts  
19 of the state for guidance, counseling, and testing; and (c)  
20 improvement and expansion of the statistical services of the  
21 state department .....\$ 181,000.00

22 2. SPECIAL EDUCATION

23 For education aid to physically and mentally handicapped  
24 children, and to migratory workers and children of migratory  
25 workers. To be used for reimbursement to school districts

1 or county boards in accordance with the provisions of  
 2 chapter two hundred eighty-one (281) of the Code, and  
 3 school districts or county boards operating education programs  
 4 for migratory workers and children of migratory workers.  
 5 Not more than thirty-five thousand (35,000.00) dollars of  
 6 this appropriation may be used in each year of the biennium  
 7 for reimbursement to school districts or county boards for  
 8 education programs for migratory workers and children of  
 9 migratory workers .....\$ 3,500,000.00

10 Sec. 2. There is hereby appropriated from the general fund  
 11 of the state to the department of public instruction for the  
 12 biennium beginning July 1, 1969 and ending June 30, 1971,  
 13 the following amount, or so much thereof as may be necessary,  
 14 to be used for the purpose designated:

15 1. EQUALIZATION AID TO SCHOOL DISTRICTS  
 16 For the state's equalization aid payment to high school  
 17 districts as provided in chapter three hundred fifty-six  
 18 (356) of the Acts of the Sixty-second General Assembly.  
 19 For the first year of the biennium .....\$112,000,000.00  
 20 For the second year of the biennium ..... 115,000,000.00  
 21 Total for the biennium .....\$227,000,000.00

22 Sec. 3. No moneys appropriated by this Act shall be used  
 23 for capital improvements.

24 Sec. 4. The provisions of chapter eight (8) of the Code  
 25 are hereby made a part of this Act.

26 Sec. 5. Where any of the laws of this state are in conflict  
 27 with this appropriation Act, the provisions of this Act shall  
 28 govern for the biennium.
