A BILL FOR

- 1 An Act to legalize and validate the proceedings of the Town
- 2 Council of the Town of Pierson, in the County of Woodbury,
- 3 State of Iowa, authorizing and providing for the issuance
- 4 of Town Hall and Fire Station Bonds and for the levy of
- 5 taxes for the payment of said bonds and declaring the bonds
- 6 issued pursuant to said proceedings to be enforceable obli-
- 7 gations of said Town.
- 8 WHEREAS, it appears from the records of the Town of Pierson,
- 9 in the County of Woodbury, State of Iowa, that a special elec-
- 10 tion held in and for said Town on January 6, 1969, the propo-
- 11 sition of purchasing land and constructing a combined Town Hall
- 12 and Fire Station and contracting indebtedness for such purposes
- 13 not exceeding \$48,000 and issuing bonds for such purpose not
- 14 exceeding \$48,000 and levying a tax annually upon the taxable
- 15 property in said Town not exceeding 11 mills per annum for the
- 16 payment of such bonds and the interest thereon, was approved
- 17 by more than 60% of the total number of votes cast for and
- 18 against said proposition, and in reliance upon said election
- 19 said Town Council thereafter by resolution authorized and pro-
- 20 vided for the issuance of Town Hall and Fire Station Bonds to
- 21 the amount and for the purpose aforesaid and made provision
- 22 for the levy of taxes to pay said bonds and the interest
- 23 thereon; and
- 24 WHEREAS, doubts have arisen concerning the validity and
- 25 legal sufficiency of said election and proceedings and pro-

1 visions made for the issuance and payment of said bonds and it
2 is deemed advisable to put such doubts and all others that
3 might arise concerning the same forever at rest; NOW, THEREFORE,

4 *Be It Enacted by the General Assembly of the State of Iowa:*

5 Section 1. That all proceedings heretofore taken by the
6 Town Council of the Town of Pierson, in the County of Woodbury,
7 State of Iowa preliminary to and in connection with the election
8 on said bonds held in said Town on January 6, 1969, and provid-
9 ing for the issuance and delivery of Town Hall and Fire Station
10 Bonds of said Town in the amount of \$48,000 pursuant to said
11 election, and for the levy of taxes to pay said bonds and the
12 interest thereon, are hereby legalized, validated and confirmed
13 and said Town Hall and Fire Station Bonds issued, sold and de-
14 livered pursuant to and in accordance with said proceedings are
15 hereby declared to be legal and to constitute the valid and
16 binding obligations of said Town of Pierson.

17 Section 2. This Act being deemed of immediate importance,
18 shall be in full force and effect from and after its passage
19 and publication in "The Pierson Press," a newspaper published
20 at Pierson, Iowa, and in "The Correctionville News," a news-
21 paper published at Correctionville, Iowa, without expense to
22 the State.

EXPLANATION OF HOUSE FILE 431

The purpose of this act is to legalize proceedings of the town of Pierson, Woodbury County, whereby bonds were issued and taxes authorized to be levied for the purchase of land and the constructing of a combined town hall and fire station.
