- 1 An Act to coordinate various statutes with the department of
- 2 social services Act.
- 3 *Be It Enacted by the General Assembly of the State of Iowa:*
- 4 Section 1. Chapter two hundred nine (209), Acts of the
- 5 Sixty-second General Assembly, section thirteen (13), line
- 6 six (6), is amended by inserting after the words "Mount
- 7 Pleasant" the word "Mental".

10 3. Such recommendations as to changes in laws under its
11 administration as the commissioner may deem necessary.

12 4. The observations and recommendations of the commissioner
13 and the council of social services relative to the programs of
14 the department.

15 5. Such other information as the commissioner or council
16 of social services may deem advisable, or which may be re-
17 quested by the governor or by the general assembly."

EXPLANATION OF HOUSE FILE 435

Section 5, chapter 209, Acts of the Sixty-second General Assembly, provides that all powers, duties, functions, and programs of the board of control of state institutions, the board of social welfare, and the department of social welfare are transferred to the department of social services. In connection with such transfer, the proposed bill accomplishes the following:

1. Corrects and clarifies the Code in regard to names (Sec. 1), duplication (Secs. 9, 11, 20, and 61), and references (Secs. 4, 5, 14, and 63);
2. Reestablishes language adopted by previous legislatures, considered material, but made ineffective by repeal of parent Code section (Secs. 2, 6, and 62);
