A BILL FOR

1 An Act relating to county and memorial hospital funds, the
2 control and investment thereof.
3 *Be It Enacted by the General Assembly of the State of Iowa:*
4 Section 1. Section thirty-seven point nine (37.9), Code
5 1966, is hereby amended by adding the following:
6 "The commissioners having the management and control of a
7 memorial hospital shall, within ten days after their appoint-
8 ment, qualify by taking the usual oath of office, but no bonds
9 shall be required of them except as hereinafter provided. The
10 commissioners shall organize by electing a chairman, secretary,
11 and treasurer. The secretary and treasurer shall each file
12 with the chairman of the commission a surety bond in such sum
13 as the commission may require, with sureties approved by the
14 commission, for the use and benefit of the memorial hospital.
15 The reasonable costs of such bonds shall be paid from operating
16 funds of the hospital. The secretary shall immediately report
17 to the county auditor and county treasurer the names of the
18 chairman, secretary, and treasurer of the commission. The
19 commission shall meet at least once each month. Three members
20 of the commission shall constitute a quorum for the transaction
21 of business. The secretary shall keep a complete record of its
22 proceedings.
23 Memorial hospital funds shall be received, disbursed, and
24 accounted for in the same manner and by the same procedure as
25 provided by section three hundred forty-seven point twelve

1 (347.12) of the Code.”

2 Sec. 2. Section four hundred fifty-three point one (453.1),
3 Code 1966, as amended by chapter three hundred one (301), sec-
4 tion three (3), and chapter three hundred fifty-nine (359),
5 section two (2), Acts of the Sixty-second General Assembly,
6 is hereby further amended as follows:

7 1. By inserting before the words “and school” in line two
8 (2) the words “memorial hospital”.

9 2. By inserting after the word “council,” in line ten (10)
10 the words “memorial hospital commission,”.

11 Sec. 3. Section four hundred fifty-three point four
12 (453.4), Code 1966, as amended by chapter three hundred one
13 (301), section four (4), Acts of the Sixty-second General
14 Assembly, is hereby further amended by inserting in line five
15 (5) after the semicolon the following: “by a memorial hospital
16 treasurer, in a bank located within this state which shall be
17 selected by such memorial hospital treasurer and approved by the
18 memorial hospital commission;”.

19 Sec. 4. Section four hundred fifty-three point eleven
20 (453.11), Code 1966, as amended by chapter three hundred one
21 (301), section five (5), Acts of the Sixty-second General
22 Assembly, is hereby further amended by inserting in line two
23 (2) before the word “or” the words “, memorial hospital”.

EXPLANATION OF HOUSE FILE 462

This act provides a method for the organization of the commissioners of a memorial hospital commission. In addition the manner of deposit and investment of memorial hospital funds is provided for by incorporating references to such funds into chapter 453 of the Code, which provides for the general administration deposit and investment of public funds.
