## A BILL FOR

- 1 An Act relating to county public hospitals.
- 2 *Be It Enacted by the General Assembly of the State of Iowa:*
- 3 Section 1. Section three hundred forty-seven point seven
- 4 (347.7), Code 1966, as amended by chapter three hundred (300),
- 5 sections one (1) and three (3), Acts of the Sixty-second Gen-
- 6 eral Assembly, is hereby further amended by inserting at the
- 7 end thereof the following:
- 8 "For purposes of this section, a hospital is not established
- 9 until it is constructed, staffed, and receiving patients."

### EXPLANATION OF HOUSE FILE 624

The purpose of this bill is to prevent counties from placing the levy for "improvement, maintenance and replacement" before a county hospital is finally constructed.

SENATE AMENDMENT TO HOUSE FILE 624

- 1 Amend House File 624 as follows:  
2 1. By striking lines 8 and 9 and inserting in lieu thereof the  
3 following: *House*  
4 "No levy shall be made for the improvement, maintenance, *amended*  
5 or replacements of the hospital until the hospital has been *5-21*  
6 constructed, staffed, and receiving patients."  
7 2. By adding the following new section:  
8 Sec. 2. Section three hundred forty-seven point one  
9 (347.1), Code 1966, is hereby amended as follows:  
10 1. By striking lines fourteen (14) and fifteen (15) and  
11 inserting in lieu thereof the words "such purpose."  
12 2. By striking from lines twenty-three (23) and twenty-  
13 four (24) the words "provided for herein" and inserting in lieu  
14 thereof the words "as limited by the provisions of sections  
15 three hundred forty-seven point five (347.5) and three hundred  
16 forty-seven point seven (347.7) of the Code".
