A BILL FOR

- 1 An Act relating to inclusion of students in attendance at
- 2 area vocational schools and area community colleges within
- 3 the state scholarship and loan program.
- 4 *Be It Enacted by the General Assembly of the State of Iowa:*
- 5 Section 1. Section two hundred sixty-one point two
- 6 (261.2), subsection four (4), Code 1966, is hereby amended
- 7 as follows:
- 8 1. By striking the word "or" from line six (6) and in-
- 9 serting in lieu thereof a comma.
- 10 2. By inserting in line six (6) after the word "colleges"
- 11 the words ", area vocational schools, or area community
- 12 colleges".

EXPLANATION OF HOUSE FILE 71

This bill allows Iowa students attending area vocational schools and area community colleges to apply for scholarships administered by the Higher Education Facilities Commission in the same manner as Iowa students attending Iowa universities and colleges.

- 1 Amend House File 71 as follows:
- 2 1. By striking everything in line eleven (11) after the word
- 3 "schools," and all of line twelve (12) and inserting in lieu
- 4 thereof the following: "area community colleges, or schools of
- 5 professional nursing."
- 6 2. Amend the title by striking everything after the word
- 7 "schools" in line two (2) and all of line three (3) and inserting
- 8 in lieu thereof the following: ", area community colleges, and
- 9 schools of professional nursing."
