A BILL FOR

- 1 An Act relating to annual registration decal or sticker fees.
- 2 *Be It Enacted by the General Assembly of the State of Iowa:*
- 3 Section 1. Section three hundred twenty-seven B point one
- 4 (327B.1), Code 1966, is hereby amended by striking from lines
- 5 thirty-six (36) and thirty-seven (37) the words "twenty-five
- 6 cents" and inserting in lieu thereof the words "one dollar".

EXPLANATION OF HOUSE FILE 760

This bill increases the annual decal fee from twenty-five cents to one dollar for registration by motor carriers of their Interstate Commerce Commission operating authority with the Iowa State Commerce Commission. Iowa law requires display of the decal on each vehicle operated on Iowa highways by interstate motor carriers.
