A BILL FOR

1 An Act to appropriate from the general fund of the state of
2 Iowa for the biennium beginning July 1, 1969 and sending
3 June 30, 1971, to the Iowa state fair board.

4 *Be It Enacted by the General Assembly of the State of Iowa:*

5 Section 1. For the Iowa state fair board there is hereby
6 appropriated from the general fund of the state for each year
7 of the biennium beginning July 1, 1969 and ending June 30,
8 1971, the following amounts, or so much thereof as may be
9 necessary, to be used in the manner designated:

10 FAIR BOARD

11 a. Fair board, Iowa state

12 For maintenance of buildings and

13 grounds \$ 60,000.00

14 For premiums 10,000.00

15 The salary of the secretary of the state

16 fair board shall be fifteen thousand (15,000)

17 dollars per annum to be paid out of the fund

18 of the state fair board.

19 b. Agricultural societies (local fairs)

20 For state aid 210,000.00

21 The appropriations for state aid to agri-

22 cultural societies shall be deemed conditional

23 on full compliance with all other statutes

24 which regulate and prescribe the conditions

25 under which such aid is payable. In no case

1 shall any county receive more than two thou-
 2 sand one hundred (2,100) dollars, except that
 3 in a county where there are two definitely
 4 separate county extension offices, each such
 5 society shall receive state aid in such amount
 6 as it would be entitled to if it were the only
 7 society in the county. In counties having more
 8 than one fair entitled to state aid, the state
 9 aid available for the county shall be prorated
 10 to said fairs on the basis of cash premiums
 11 paid by said fairs.

12 Total\$280,000.00

13 Sec. 2. There is hereby appropriated from the general fund
 14 of the state of Iowa to the state fair board the sum of one
 15 hundred thousand (100,000) dollars, or so much thereof as may
 16 be necessary, to be used for major repairs to the buildings.

17 Contracts for improvements for which funds are appropriated
 18 by this section shall be submitted by the state fair board to
 19 the governor and the state comptroller, except that items com-
 20 monly known as change orders need not be submitted to the
 21 governor and the state comptroller unless such change orders
 22 actually increase the total cost of that particular project.

23 The state fair board, the governor and the state comptroller
 24 are hereby authorized to obtain federal grants to the state to
 25 be used in connection with the funds appropriated by this sec-
 26 tion.

27 Any unencumbered balance remaining as of June 30, 1971, of
 28 the appropriation of this section shall revert to the general
 29 fund of the state as of June 30, 1971.

30 Sec. 3. All federal grants to and the federal receipts of
 31 these departments and divisions thereof are hereby appropriated
 32 for the purpose set forth in such federal grants or receipts.

33 Sec. 4. Where any of the laws of this state are in conflict
 34 with this Act, the provisions of this Act shall govern for the
 35 biennium.
