A BILL FOR

1 An Act to appropriate from the general fund of the state of
2 Iowa for the biennium beginning July 1, 1969 and ending
3 June 30, 1971, to the state department of health.

4 *Be It Enacted by the General Assembly of the State of Iowa:*

5 Section 1. There is hereby appropriated for the state
6 department of health from the general fund of the state of Iowa
7 for each year of the biennium beginning July 1, 1969 and ending
8 June 30, 1971, the following amounts, or so much thereof as may
9 be necessary, to be used in the manner designated:

11	For salaries, support, maintenance	
12	and miscellaneous purposes	\$ 213,550.00
13	2. Chronic illness and aging service	
14	For salaries, support, maintenance and	
15	miscellaneous purposes	26,110.00
16	3. Air pollution control commission

20	For salaries, support, maintenance and	
21	miscellaneous purposes	174,280.00

16	For salaries, support, maintenance and

18	11. Community health service	
19	For salaries, support, maintenance and

24	Total	<u>\$1,558,940.00</u>

25 Sec. 2. The salary of the commissioner of the state depart-
 26 ment of health shall be twenty-three thousand (23,000) dollars
 27 for each year of the biennium.

28 Sec. 3. All federal grants to and the federal receipts of
 29 this department and divisions thereof are hereby appropriated
 30 for the purpose set forth in such federal grants or receipts.

31 Sec. 4. No moneys appropriated by this Act shall be used for
 32 capital improvements.

33 Sec. 5. Where any of the laws of this state are in conflict
 34 with this Act, the provisions of this Act shall govern for the
 35 biennium.
