A BILL FOR

- 1 An Act to legalize and validate the proceedings taken for the
- 2 creation, organization and establishment of the county
- 3 conservation board of Scott county, Iowa, and all acts
- 4 and proceedings taken by said board and its officials.
- 5 WHEREAS pursuant to statutory provisions now contained in
- 6 Chapter 111A of the Code of Iowa and an election held in said
- 7 county on November 6, 1956, the board of supervisors of
- 8 Scott county, Iowa, has heretofore created a county conserva-
- 9 tion board in and for said county, members of said conserva-
- 10 tion board have been appointed from time to time, officials
- 11 thereof have been selected, various proceedings and official
- 12 actions have been taken by the conservation board and its
- 13 officials and taxes have been levied for county conservation
- 14 purposes in said county for over 10 years, and the existence
- 15 of said county conservation board is of general public interest
- 16 and vital to the carrying out of conservation activities
- 17 within the county; and
- 18 WHEREAS doubts have arisen concerning the legal sufficiency
- 19 of the proceedings taken for the creation of said county
- 20 conservation board, the appointment of its officials and the
- 21 proceedings and official actions taken by this board and its
- 22 officials, and it is deemed advisable and necessary to put
- 23 such doubts and all others that might arise concerning the same
- 24 forever at rest; now, therefore,
- 25 *Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. That all proceedings heretofore taken in
2 connection with the creation, organization and establishment
3 of the county conservation board of Scott county, Iowa, and
4 all acts and proceedings heretofore taken by said board and
5 its officials in carrying out their duties and responsibilities
6 are hereby legalized, validated and confirmed.
- 7 Sec. 2. This Act being deemed of immediate importance shall
8 be in full force and effect from and after its passage and
9 publication in The Times-Democrat, a newspaper published at
10 Davenport, Iowa, and in the Bettendorf News, a newspaper
11 published at Bettendorf, Iowa, without expense to the state.

EXPLANATION OF HOUSE FILE 799

This Act legalizes proceedings wherein Scott County created a county conservation board, appointed members for such board, and levied taxes for county conservation purposes.
