A BILL FOR

- 1 An Act to appropriate from the general fund of the state of
- 2 Iowa to the department of public safety for construction
- 3 of a highway patrol district headquarters building at
- 4 Oelwein.
- 5 *Be It Enacted by the General Assembly of the State of Iowa:*
- 6 Section 1. There is hereby appropriated to the division
- 7 of highway patrol, department of public safety, from the
- 8 general fund of the state of Iowa, the sum of twenty-two
- 9 thousand (22,000) dollars, or so much thereof as may be
- 10 necessary, to be used for the construction of a new district
- 11 headquarters building at Oelwein.
- 12 Sec. 2. Before any of the funds appropriated by this Act
- 13 shall be expended it shall be determined by the department
- 14 of public safety, with the approval of the executive council,
- 15 that the expenditures shall be for the best interests of
- 16 the state.
- 17 Sec. 3. Any unencumbered balance remaining as of June 30,
- 18 1971 of the fund appropriated by this Act shall revert to the
- 19 general fund of the state as of June 30, 1971.

EXPLANATION OF HOUSE FILE 816

This bill will appropriate additional funds for the highway patrol district headquarters building in Oelwein, to enable the highway patrol to construct the building. Oelwein has contributed land and the necessary sewer and water facilities, at a cost of approximately \$12,000.00.
