A BILL FOR

1 An Act to appropriate from the general fund of the state of
2 Iowa for various agricultural associations and industries.

3 *Be It Enacted by the General Assembly of the State of Iowa:*

4 Section 1. For the department of agriculture there is
5 hereby appropriated from the general fund of the state for
6 each year of the biennium beginning July 1, 1969 and ending
7 June 30, 1971, the following amounts, or so much thereof as
8 may be necessary, to be used by the following associations for
9 the purposes and objects for which such associations exist and
10 for the general development of marketing and other economic
11 activities of the agricultural industry of Iowa:

12	1. Iowa beef cattle producers associations	\$20,000.00
13	2. Iowa crop improvement association	3,500.00
14	3. Iowa state dairy association	20,000.00
15	4. Dairy calf club exposition	2,000.00
16	5. State horticultural society	16,500.00
17	6. Iowa state sheep association	14,500.00
18	7. Iowa swine producers association	20,000.00
19	Total	<u>\$96,500.00</u>

20 Sec. 2. The funds distributable for the dairy calf exposi-
21 tion and state horticultural society shall be distributed as
22 authorized in chapters one hundred eighty (180) and one hun-
23 dred eighty-six (186) of the Code. Funds to the other associ-
24 ations shall be distributed in quarterly installments on war-
25 rant of the state comptroller upon the certificate of the

- 1 secretary of agriculture.
- 2 Sec. 3. Any unencumbered balance remaining as of June 30,
- 3 1971, of the funds appropriated by this Act, shall revert to
- 4 the general fund of the state as of June 30, 1971.
