## A BILL FOR

1 An Act to make appropriations to certain counties and named  
 2 persons in settlement of claims made against the state of  
 3 Iowa.

4 *Be It Enacted by the General Assembly of the State of Iowa:*

5 Section 1. There is hereby appropriated out of the general  
 6 fund of the state of Iowa to the following named persons and  
 7 counties the amount set opposite their respective names in  
 8 full settlement of all claims which they may have against the  
 9 state of Iowa, to-wit:

8 Sec. 2. The state comptroller is hereby authorized and  
 9 directed to issue his warrant to the above named counties and  
 10 persons in the amount set opposite their names, and the trea-  
 11 surer of the state is hereby authorized and directed to pay  
 12 the same from the general fund of the state of Iowa.

13 Sec. 3. Receipt of said sums by said counties and persons  
 14 shall be in full settlement of all claims they may hold against  
 15 the state of Iowa, as above indicated, claims for which were  
 16 presented to the joint claims committee of the Sixty-third  
 17 General Assembly.
