## A BILL FOR

- 1 An Act relating to acknowledgments by notaries public.
- 2 *Be It Enacted by the General Assembly of the State of Iowa:*
- 3 Section 1. Section five hundred fifty-eight point twenty
- 4 (558.20), Code 1966, lines nine (9) to twelve(12), inclusive,
- 5 is amended by striking the words "county of his appointment or
- 6 in any county in which he has filed with the clerk of the dis-
- 7 trict court a certified copy of his certificate of appointment"
- 8 and inserting in lieu thereof the word "state".
- 9 Sec. 2. Section five hundred fifty-eight point thirty-nine
- 10 (558.39), Code 1966, line thirty-two (32), is amended by strik-
- 11 ing the words "in and for said county" and inserting in lieu
- 12 thereof the words "in the state of Iowa".

### EXPLANATION

Chapter ninety-seven (97), Acts of the Sixty-third General Assembly, First Session, abolished the necessity for notaries public to limit their services to the county of appointment or where certificates are filed.

- 1 Amend Senate File 1009 as follows:
- 2 1. Line five (5), strike "county of his appointment".
- 3 2. Strike all of line eight (8).
- 4 3. Place a period at the end of line seven (7).
- 5 4. Strike section two (2) and insert:
- 6 Sec. 2. Section five hundred fifty-eight point thirty-nine
- 7 (558.39), Code 1966, is amended as follows:
- 8 1. Line thirty-two (32), strike "in and for said county"
- 9 and insert "acting in the county of his appointment".
- 10 2. Lines forty-six (46) and forty-seven (47), strike "in
- 11 and for said county" and insert "acting in the county of his
- 12 appointment".
