A BILL FOR

- 1 An Act relating to a minimum motor vehicle registration fee.
- 2 *Be It Enacted by the General Assembly of the State of Iowa:*
- 3 Section 1. Chapter one hundred ninety-seven (197), section
- 4 two (2), Acts of the Sixty-thre General Assembly, First Session,
- 5 is amended by inserting in line twenty-one (21) after the word
- 6 "dollar" the words ", except that any such fee so computed shall
- 7 not be less than five dollars,".

EXPLANATION

This section was amended by the Sixty-second General Assembly by adding the above minimum motor vehicle registration fee. It was inadvertently lost in recodification of this section at the latest session of the general assembly.
